Camp Rules, Authorization, Assumption and Acknowledgement of Risks, Release of Liability (Hereinafter Rules)

1. I realize that I will have to be present with my child(ren) who are under the age of 5 and actively participate in their activities while they are at Spruce Point Inn. I understand that young children may get hurt while playing with other children and while engaging in physical activities, and that there is a risk of property damage, severe injury, or death inherent in my child participating at SPI classes and activities. I also understand that there are risks inherent in any physical activity program, including the use of equipment, such as that provided for use at SPI, which may or may not be obvious and which may pose serious threats to any person if used improperly. I acknowledge that the equipment at SPI is designed for young children, not for adolescents or adults. Although I understand that SPI has attempted to create an injury free play area for my child(ren), a child needs constant attention, and I agree to be either personally responsible for providing that attention, or to appoint another caregiver to provide that attention.
2. I agree to follow any instruction or rules established by SPI regarding my child(ren)s activities, whatever written or orally given by SPI personnel, including but not limited to these Rules. I understand and agree that at any time, SPI reserves the right to require me to remove my child(ren) from any activity for any reason and/or to cancel the child(ren)s enrollment for any reason.
3. I agree to discuss any concerns with my child(ren) and SPI staff, which I think may affect my child(ren)s ability to safely participate in any activities or to use any equipment with a staff member of SPI.

I UNDERSTAND IT IS A LEGALLY BINDING AGREEMENT AND WAIVES CERTAIN LEGAL RIGHT OF MINE, INCLUDING, BUT NOT LIMITED TO A RELEASE, WAIVER, PROMISE NOT TO SUE AND HOLD HARMLESS SPI FOR ALL CLAIMS. THIS AGREEMENT SHALL BE BINDING UPON MYSELF, MY CHILD(REN), OUR ESTATES, SUCCESSORS, AND ASSIGNS.
